

Health Care Matters - Quick Hits

The **Health Care Plan for CN Pensioners** brochure is complex, there are lots of pages and it is tough to find what you need. Here are a few informative hints to help maximise your benefits.

Get 100 not 90

You are entitled to 100 pills for most prescriptions. Get your Dr. to prescribe the max and you will save a bit more each time

Snowbirds and Medications

Most provinces now allow up to a 200 day supply of travel prescriptions and our Plan does as well. HOWEVER you need to plan in advance as each province has different rules as do some pharmacies. Two or more weeks before your trip south, talk to the pharmacy and if necessary call the number on the back of your Card to see what is required.

Maximize your Deductible

Most of our members pay the lower Option premiums but have higher deductibles for their extended health care (EHC) benefits. When you need to use one of these benefits and pay all or part of your deductible, review the plan brochure for other items you may need and make sure you buy/claim them in that same calendar year. READ the brochure to see all your entitlements.

Massage Therapy & Doctors Prescription

While you don't need a prescription for most EHC specialists, you need one for Massage Therapy. It is good for one year only and you will then need another Doctor recommendation.

Need a Special or Unusual Vaccine

Shingles, Pneumonia, Yellow Fever, Hep A/C or others. If your Doctor prescribes one of these OR you are travelling to some far off third world country, these can be a real added cost. Unlike most Plans ours covers these kinds of vaccines up to a max of \$500 per year. Ask your Doctor or Pharmacist about what your needs are.

Going into the hospital

Most of our Plan options cover semi-private rooms. In some cases, the hospital will ask you before being admitted if you have coverage and do you want this room if available. If you say YES and you get lucky and get the room, they will charge you and you then claim some of that cost back. However, if you say NO and you still get lucky and get a semi private room, there is no cost to you. Remember your hospital deductibles as well.

Do You Really Need Eye Glasses

Consider this – If you're in Option D, it provides 1 pair of glasses every 3 years for up to \$200. Option C1 has exactly the same deductibles BUT no eyeglass coverage. When you get your renewal letter next November, look at the difference in the rates between D and C1 and see if you are getting the value for the cost. You might be surprised what you see! By the way, same holds true for C2 and C3, same general coverage, higher deductibles, but lower monthly costs – figure out what is best for you.

Read the Brochure

I want to encourage you to read the Brochure. Yes it is boring, but if you want to maximise your benefits it might be helpful.

The Plan Brochure is on the CNPA National Website – CNPENSIONERS.ORG under HealthCare and Blue Cross.

Remember – Our Plan is fully funded by your premiums only and is managed by volunteer CN Pensioners. Medavie Blue Cross merely administers your claims on our behalf. Normal inflation is causing Drug and EHC costs to rise every year, just like your hydro and other bills. We are trying to keep the increases to a minimum while maintaining benefit coverage levels.

He was later transferred to the Symington Yards and assisted in the development and construction of it. He later transferred to the Transcona Shops as a supervisor and eventually had to take early retirement because of health/heart issues. He died at the St. Boniface Hospital on November 17, 1983.

Agnes and Leo were married on April 20, 1944 and resided their entire lives in St. Boniface. They had 5 children, Robert (Bob), Paul, Jacqueline (Lynn), Claude and Gilles. All her children married and produced twelve grandchildren and fifteen great grandchildren.

Agnes was a stay-at-home Mom until her two youngest children were of high school age. She found a job and became a receptionist for a medical doctor in St. Boniface until her retirement.

After Leo's passing in 1983, Agnes found it too difficult to maintain the family home and moved to an apartment unit within St. Boniface and lived there until 2017. After numerous tests, the hospital doctors felt it was unsafe for her to remain living alone and recommended she be placed in a care home, also in St. Boniface and she remains there.

Her health has seriously diminished since COVID and the residents there spent months without visitors. She is no longer able to see, and her hearing is very limited.

Agnes is very appreciative of the 100th birthday gift from the CN Pensioners Association of MB and proud of being made a member of the centenarian club.

Honoring The Sodomlak / Gendron Family Long time Educators and Railroaders in Transcona

As a tribute to their late Grandfather Lewis Gendron, in 2016 the children of Jean Sodomlak submitted their Grandfather's name to be used as a street name in the Transcona area. They had initially hoped the street naming would be in time for the celebration of their Mother's (Jean Sodomlak) 85th birthday in 2017. Finally in 2022, the family was notified that the street name "Gendron Way" was to be included in a new residential site in East Transcona.

Lewis Erwin Gendron (1896-1973) originally from Ontario, came to Manitoba in 1922. Graduating with a Bachelor of Arts Degree in English and History, Lewis' teaching career spanned 47 years which included 12 years at Transcona Collegiate (Central School) and 15 years at Miles MacDonnell. During those years, he lived both in Transcona (Winona Street) and East Kildonan (Kimberly Street).

Lewis served his community in many capacities. He was the First President of the Transcona Curling Club. He served on the Vestry of St George's Anglican Church in Transcona, was a member of the Transcona Masonic Lodge, served as the Treasurer of the Manitoba Teachers' Society for 27 years, served as the Secretary of the Native Sons of Canada for 18 years and 2 years as President. Lewis was a man committed to education and the community to which he belonged. Three of his grandchildren have followed him into Education as teachers and school administrators.

The CN Connection: Lewis' daughter, Jean, married Walter Sodomlak in 1953. They were original and long-time residents on Ravelston Avenue West in Transcona where they raised a family of five: 4 daughters and one son. Both Jean and Walter were well known in the Transcona community where they fostered many lifelong friendships.

Walter Sodomlak was a long-time employee of CN working in the Motive Power Shops in Transcona for 38 years retiring in 1985, sadly passing away in 2003. Jean also worked at CN for a total of about 13 years, in the Stores Department in Transcona as well as in the CN Tax Department. Their son Jerry and daughters Laurie and Sandy carried on the CN torch during the summer months while attending University and pursuing their careers in education.

We continue to try and engage CN on the topic of re-establishing access to the CN Fitness Centers across the system for our members. They are currently available only to active CN employees due to their enhanced cleaning protocols. Once we get word that our access has been re-established we will be sure to provide that advice to all members, through the various social media points as well as newsletters. We can't provide any specific timeline for that as it is completely within CN's control.

Primary Caregiver Tax Credit (MANITOBA RESIDENTS) https://www.gov.mb.ca/finance/tao

The Primary Caregiver Tax Credit provides recognition and financial support to individuals who serve as primary caregivers for more than 90 days. This program builds upon regional home care services and is intended to help care recipients remain independent as long as possible. Care recipients may have cognitive, physical or behavioral barriers. Therefore, they require assistance in completing personal care and home making activities and in using community resources so that they can remain in the community longer.

The primary caregiver may be a spouse, other relative, neighbour, or friend who provides care without remuneration. The individual must be assessed as requiring Care Levels 2, 3, or 4 while living at home. Examples include those with a disability, people with life threatening illnesses and others needing care and supervision for periods of more than 90 days.

NEW:

- 1. As of the 2018 tax year, an individual tax filer may claim a flat tax credit of \$1,400 per year for providing the unpaid care.
- 2. Manitoba caregivers may substantiate their self-assessed eligibility by completing a Registration Form, sending a copy to the Manitoba Tax Assistance Office, and making a claim on their personal income tax return (MB479).
- 3. It is recommended that tax filers retain original copies of all relevant documentation in case it is needed by Manitoba Finance or the Canada revenue Agency to verify or substantiate a tax credit claim.
- 4. This credit is refundable and not income tested. This means you can claim it even if you do not have taxable income. The credit may defray your caregiver expenses such as shopping, transport, outings and respite.

Who is Eligible

The care recipient must:

- be a resident of Manitoba;
- reside in an area under the jurisdiction of a Regional Health Authority;
- reside in a private residence (e.g., not a group home, foster home, hospital, or personal care home, in supportive housing, or on a reserve);
- assessed as having care level requirements equivalent to level 2 or higher (see Registration Form); and
- designate only one primary caregiver to claim this credit.

The primary caregiver must:

- be a resident of Manitoba;
- provide caregiving for longer than 90 days;
- personally provide care or supervision to the care recipient without reward or compensation of any kind; and
- not be the spouse or common-law partner of a person who receives compensation or reward for providing care to a qualified care recipient.

- 2. Claim the Primary Care Giver Tax Credit on your personal income tax return beginning in the year of registration.
- 3. Keep original copies of all relevant documentation in case it is requested by Manitoba Finance or the Canada Revenue Agency to substantiate your tax credit claim

Additional Information:

If caregiving continues from year to year without interruption, the initial 90-day qualification requirement is not repeated. A change in the primary caregiver designated by a care recipient requires a new Registration Form and a 90-day qualification period by the new caregiver. Caregivers do not have to submit new registrations forms for subsequent years. Caregivers who receive Employment and Income Assistance (EIA) are eligible to claim the full credit without reduction.

even a chicken mascot. "It's all in good fun," explains Dan. "Through the hard work of many volunteers, we raise tens of thousands of dollars each year for local community organizations like the rec center and scholarships for high school students." 

Tick Season 2023 is Here - Be Tick Smart!

What is Lyme Disease? Lyme Disease and other tick-borne illnesses are infections by disease-causing pathogens such as viruses, parasites, and bacteria that are contracted through the bite of an infected black legged tick (also known as a deer tick). Lyme can be transmitted by other ticks as well, although this is



less common. In some Provinces other tick-borne illnesses are also reportable such as in Manitoba:

- ♦ Borrelliosis (Lyme) first reportable 2009
- ♦ Anaplasmosis first reportable 2015
- ♦ Babesiosis first reportable 2015

Emerging & Other Tick-borne Infections

- ♦ Borrellia Miyamotoi this Borrelia strain typically does not produce an EM rash and can be transmitted by larval black-legged ticks which are typically active from late spring through to late summer, peaking in August.
- Deer Tick Virus (Powassan Virus). Although transmission time is not 100% clear for any tick-borne infection, this virus can be transmitted in a little as 15 minutes after attachment.
- ♦ Other strains of Borrelia

Prevention:

- Walk in the center of a trail; avoid leaf litter and long grass
- Wear light colored clothing, long pants and tuck them in your socks
- Wear bug repellant containing at least 20% deet
- Shower or bathe after being outdoors
- Do a proper full body tick check (eg: hair, scalp, ears, armpits, waist, groin, bellybutton, behind the knee)
- Don't forget to check your clothes and your pets for ticks

How to Remove a Tick:

- Use fine-tipped tweezers to grasp the tick as close to the skin's surface as possible.
- Pull upward with steady, even pressure. Don't twist or jerk the tick; this can cause the mouth-parts to break off and remain in the skin. If this happens, remove the mouth-parts with tweezers.
- After removing the tick, thoroughly clean the bite area and your hands with rubbing alcohol, an iodine scrub, or soap and water.
- Save the tick in a sealed tight container with a damp cotton ball so it can be identified and available for future testing.
- Never crush a tick with your fingers. Disinfect your tweezers!!
- With tick removal the head may get stuck, remove as you would with a splinter or sliver. Remove with a sterilized needle or tweezers. Wet the bite spot first. If the head of the tick remains inside, the salivary glands may still be there so risk of contamination. If you can't get it out, go to your doctor or a Walk-in Clinic.
- Do not use other methods as they might irritate the tick thus increasing the chances that the tick might produce extra saliva and then vomits its stomach into you.

Life brought back to Winnipeg Railway Museum as plans to reopen are in the works.









The Winnipeg Railway Museum has new life. After being told it had to move or close in 2021 due to building code issues triggered by a renovation, plans to reopen the museum are now full steam ahead.

The Winnipeg Railway Museum has signed a new 25-year lease to stay at Union Station. The lease was signed in November 2022 with its landlord, Via Rail. As long as it tends to fire code issues in the 1911 building, it will remain.

The museum has been operating virtually since its closure on a redesigned website; https://wpgrailwaymuseum.com/exhibits

The Midwestern Rail Association, which owns the museum, is hoping to use the new lease to secure major grants and improve the overall quality of the museum.

"I'm afraid to say that one of the things that we've suffered from is that for the longest time we've been a collection of things that you can point at. And that's just not good enough when you look at today's museums," said the public relations director with the museum.

"So nowadays, we can start building proper exhibits and tell the people of Winnipeg just how important the railway really is." Despite the good news, the museum isn't completely out of the woods just yet when it comes to staying permanently at the Union Station location.

Winnipeg Transit has voiced plans in the past to convert part of the station into a rapid-transit route, which would utilize the tracks which currently house the museum.

For now, the museum is focusing on getting back up and running and hopes to finish repair work and reopen by late 2024 or early 2025.
